TENDER: HOUSE KEEPING SERVICES

KISDGGERS invited tenders for Housekeeping Services through the Open Tender System on 09th March, 2024. A total of seven bids were received by the deadline on March 27, 2024.

The technical bids were opened on June 27, 2024, at 11:00 AM in the presence of the purchase advisory committee members and vendor representatives. Upon reviewing the seven technical bids, it was determined that all vendors qualified for the next round of the tendering process, which involved the opening of financial bids.

The financial bids were opened on June 28, 2024, at 11:00 AM in the presence of the purchase advisory committee members and vendor representatives. After scrutinizing the financial bids, it was found that only the following three vendors qualified, while the remaining four were rejected for the reasons mentioned below.



REASON FOR REJECTION OF FOUR FINANCIAL BIDS:


1. Sainik Surveillance & Security
2. Secure Target & Allied
3. Sharma Enterprises
4. Kan Services

KISSDGSSRS explicitly stated in its tender document for Housekeeping and Security Services that service charges shall not be less than 2%. However, it has been observed that the four rejected vendors calculated service charges at 2%, but they based their calculations on the Minimum Rate of Wages alone. According to the tender requirements, service charges should be calculated on the subtotal of (Minimum Rate of Wages + ESIC + EPF + Bonus). This incorrect calculation method led to the rejection of their financial bids.


Additionally, Sainik Surveillance & Security did not include the bonus, which is mandatory for minimum wages below Rs. 21,000. Therefore, the financial bids of the four vendors were excluded from the Comparative Statement.






